

Opera Awards Application Guidelines

2019 Rules & Conditions

The winner of the Opera Awards receives the YMF Australia Award of \$30,000AUD presented by the Youth Music Foundation of Australia.

The main emphasis of the Opera Awards is to enable recipients to pursue overseas study and to assist in the further development of language, voice and music skills in the context of the global operatic and classical singing industry.

In 2019, for the very first time, the Opera Awards will be accepting video applications. Following an assessment of all entries, up to 8 Finalists will be chosen to compete in a private session in Melbourne on Monday 25 November 2019.

Eligibility

Applicants must fit certain criteria to be eligible for the Opera Awards.

To be eligible for the Opera Awards, a singer must:

- (i) be an Australian citizen or resident
- (ii) have sung at least 2 principal roles with a recognized professional opera company since January 2017 and provide documentation confirming this.

There is no age limit.

It is a condition of the Awards that all broadcast and television rights of your performances in any stage of the competition are freely available to MOST.

2019 Dates

Dates at any stage will not be altered to meet the needs of individual Applicants.

MOST® reserves the right to change the dates of all stages of the competition. All details may be subject to change without notice.

Entries Open - 20 May 2019 Entries Close - 23 September 2019 Finalists Notified - 25 October 2019 Adjudication Day - 25 November 2019

Repertoire

Entrants are required to prepare four (4) arias which must be sung in the original language and must include at least two different languages. If you are named as a Finalist, a legible, bound copy of the music is to be provided to the adjudication panel on the adjudication day.

Video Guidelines

While it is not necessary to have submissions professionally recorded it is critical to submit recordings of the highest possible standard. Each work must be presented as a complete unedited take and submitted as a separate file. The recording must be made within 12 months of entry and should not be edited or 'artificially enhanced'. Post production affecting the sound quality is not permitted. Videos should be uploaded to the Acceptd platform at time of entry.

Accompaniment

Competitors at the Finals on 25 November must engage an accompanist at their own expense.

Adjudication Panel

The Adjudication Panel will comprise Benjamin Northey (Chair), John Bolton-Wood, Dr Di Bresciani OAM and Roxane Hislop. Judging of the Finalists will be conducted privately in Melbourne on Monday 25 November 2019.

Travel and Accommodations

Any travel undertaken for any stage of the Competition will be at the Competitor's expense. No local travel expenses such as taxis or public transport are provided at any stage of the competition. MOST® shall not have any responsibility for Competitors' loss and/or damage during the Competition and competitors should purchase their own insurance where relevant. Competitors are responsible for their own health and injury insurance, as well as loss or damage of the instrument or luggage in case of accident, fire or theft during travel.

Prize and Conditions

The winner is required to give 2 recitals in Melbourne for our principal sponsor YMF Australia at a mutually acceptable time. The winner will also be invited to perform at the 2020 IFAC Handa Australian Singing Competition's Finals Concert in Sydney with the Opera Australia Orchestra (and if accepted will be required to attend the Piano Rehearsal, Sitzprobe, and General Rehearsal). A condition of the YMFA Award is that it is to be used predominantly for overseas study and that the funds will be distributed in a series of payments over two years. A number of prizes & opportunities may be awarded to competitors at the discretion of the Adjudicators.

Performance Rights
